# 1. Quorum

### 2. Approval of the Minutes of the HCQ Board Meeting held on 8 September 2015

M Novakoff informed the Board that members of other Canadian Harvard Clubs are seeking to increase the *David Johnston Fund Financial Aid Fund for Harvard Students from Canada* so that full scholarships to Harvard College can be offered.
